3. Agreements of Release and Indemnity

FURTHER, IN CONSIDERATION OF BEING INVITED TO PARTICIPATE IN ETREYS, TO THE MAXIMUM EXTENT ALLOWED BY LAW, DELEGATE AND GUARDIAN RELEASES, AND AGREES NOT TO BRING ANY CAUSE OF ACTION AGAINST THE ETREYS PARTIES, THE HOSTING SITE (UNIVERSITY, HOTEL, CONVENTION CENTER, HIGH SCHOOL) ON WHOSE PREMISES ETREYS WILL OCCUR (HEREINAFTER THE "LOCATION") THE AFFILIATES OF THE COOPERATIVES, AND THE RESPECTIVE DIRECTORS, OFFICERS, REPRESENTATIVES, MEMBERS, AGENTS AND EMPLOYEES OF THE PROCEEDING PARTIES (HEREINAFTER COLLECTIVELY "RELEASED PARTIES") FOR LIABILITY OR CLAIMS OF ANY NATURE, INCLUDING LOSS OR DAMAGE TO PROPERTY, PERSONAL INJURY OR DEATH, SUFFERED BY DELEGATE IN ANY WAY RELATED TO DELEGATE'S ENROLLMENT IN. PARTICIPATION IN. OR TRANSPORTATION RELATED TO ETREYS. IN ADDITION. DELEGATE AND GUARDIAN AGREES TO INDEMNIFY THE RELEASED PARTIES (THAT IS DEFEND THEM, INCLUDING SATISFACTION OF LIABILITIES, COSTS AND ATTORNEY'S FEES) FROM CLAIMS BROUGHT BY DELEGATE OR GUARDIAN, MEMBERS OF DELEGATE'S FAMILY AND ANY OTHER PERSON ARISING OUT OF DELEGATE'S ENROLLMENT IN, PARTICIPATION IN OR TRANSPORTATION RELATED TO ETREYS.
